The insurer confirms that the insured concluded in accordance with the Act. No. 170/2018 Coll., on Tours, Associated Tourism Services, Certain Terms and Conditions in Tourism and on Amendments to Certain Acts, as amended, an Insurance Policy for Tours and Associated Tourism Services in case of bankruptcy of travel agency with the insurance amount of

**€ 1 650 000,-.**

Insurance is negotiated in case that due to reasons for its bankruptcy the insured:

1. cannot ensure repatriation to a customer of a tour covered by a travel contract concluded with the insured (the "authorized person"), if such repatriation is part of a tour or a tourism service, which the insured has to provide as part of the related tourism services,
2. does not return to the authorized person the prepaid deposit or the price paid for the trip if the trip does not take place or does not return the payments received by the insured for the travel service, which is part of the combined tourism service arranged by the insured and this was not provided,
3. does not return to the authorized person the difference between the price paid by the insured and the price of the partially provided tour or partly provided tourism service if the tour or tourist service that is part of the combined tourism service arranged by the insured is provided only in part.

The insurer is obliged to pay up to the amount of the insured amount pursuant to Section 9, 5 of Act 170 / 2018Z.z.

**Start of Insurance: 01.01.2026**

**End of insurance: 31.12.2026**

The insurance is governed by the General Insurance Conditions for Travel Insurance and Associated Tourism Services in the case of the bankruptcy of the Travel Agency (ECP-VPP-INS-2020) and the Insurance Policy.
